Dear Sir or Madam,

The following points concerning the REACH Regulation are observed by Tragant Handels- und Beteiligungs GmbH:

1. Registration and Notification obligation of Substances in Articles

As a manufacturer / importer of products, we have to register substances in articles in the ECHA database only if they are contained in a total quantity of 1 tonne per year and per manufacturer.

Tragant Handels- und Beteiligungs GmbH is obliged to register substances in the SCIP database if substances of very high concern (e.g. substances meeting the criteria in Article 57) are contained in a concentration of above 0.1% weight by weight.

Should Tragant Handels- und Beteiligungs GmbH import products or have them manufactured which exceed a concentration of 0.1% weight by weight and a total quantity of more than one tonne per year, we will comply as a matter of course with the obligation to notify the ECHA and the SCIP database.

2. Obligation to Inform Customers of Products

As your supplier, Tragant Handels- und Beteiligungs GmbH will comply with the information obligations as defined in Article 33 of the REACH Regulation and provide the purchaser or the consumer with the necessary information within the period specified in the regulation.

This declaration has been prepared based on the laws and regulations currently in force and to the best of Tragant Handels- und Beteiligungs GmbH' knowledge and belief.
